5.0 Program Updates- 7:15 PM

A) Program Directors

- **5.1** Ms. Kelly Macomber, Family & Community Engagement Specialist, Ms. Vicky Butler Executive Director of Plymouth County Outreach (PCO) and Ms. Carilyn Rains, Director of Health Services
 - -Ms. Macomber explained PYDC and how the district partners with PCO. In addition, she explained how their efforts and collaboration have helped to bring Naloxboxes to every school in the district free of charge. Naloxboxes are a community based public health response to the opioid epidemic.
 - -Ms. Rains talked about the various community partnerships within PPS and health services which provide many resources for our students and staff. Ms. Rains spoke about the importance of having Naloxboxes in the school for community safety and awareness.
 - -Ms. Butler explained that the Plymouth County Outreach is a collaboration with 27 municipal police departments in Plymouth County that helps to make tools available for those struggling with addiction and to reduce fatal overdoses in the county.
 - -Ms. Macomber presented a Naloxbox to the Committee.
 - -Ms. Butler explained that inside the Naloxbox contains a dose of Narcan, a breathing barrier and instructions. She also explained the MA Good Samaritan Law, which protects individuals.
 - -Dr. Sorensen clarified that Plymouth County is 'hardest hit 'in terms of overdoses and is second to Brockton. He asked Ms. Butler if she knew why Plymouth is so high.
 - -Ms. Butler stated the size of Plymouth as well as other factors such as the diverse population play a role in the high numbers.
 - -Dr. Sorensen expressed his concerns about 'plugs' contacting students.

- -Ms. Macomber informed the committee that there will be Narcan training brought to the community.
- -Discussion was had regarding where the Narloxboxes will be placed.
- -Dr. Campbell indicated that they would be placed near the AD near the Gymnasiums.
