1.0 Call to Order 7:00 PM

1.1 Ms. Badger called the School Committee Meeting to order.

4.0 Informational Items

4.1 Agricultural Opportunities for Plymouth Public Schools- 7:05 PM.

Plymouth County Commissioner Mr. Greg Hanley presented to the School Committee agricultural opportunities and land available to Plymouth Public Schools. The land is currently being used by the Sheriff and there are approximately seventy-five acres available to the public.

Ms. Badger asked if the committee had any questions for the Commissioner. Ms. Shaw asked for clarification on the bidding process for the property and if the Plymouth Public Schools would be sharing the property.

Mr. Hanley explained that the current proposed lease is nine acres for the Sheriff's Department and is looking to collaborate with 4H as well.

Mr. Hanley explained that in speaking with the School Committee he was looking to see if the Committee had an interest in utilizing some of this land for educational purposes.

Dr. Campbell explained that Mr. Mark Duffy, CTTE Director attended a meeting with Commissioner Hanley to learn more about agricultural opportunities for Plymouth students. Currently, twelve students attend Bristol Agricultural School because Plymouth Public Schools does not have an agricultural program.

Ms. Shaw asked about the cost of the land and stated that she was not in favor of taking the land away from the Sheriff's Department.

Mr. Hanley reassured the committee that they would not be taking the land away from the Sheriff's Department.

Dr. Campbell asked Mr. Hanley to explain the level of commitment needed by CCTE Director Mark Duffy to this project if it was to move forward.

Mr. Hanley explained that this process will take years to develop. Mr. Duffy would likely partner with the 4H on this project.

Discussion was had regarding whether a vote needed to be taken on this or if it was an action item.

Ms. Badger stated that the committee must be mindful of budget constraints as they move forward.

Ms. Jackson stated that she would like to move forward with the letter of interest with the understanding that there is a lot to consider (funding) and the letter is only a step to look into the process.

Ms. Jackson moved to send a letter of interest to the Commissioner. Mr. Mogan seconded the motion.

-Ms. Badger asked for clarification on who was sending the letter.

-Ms. Jackson stated that either she or Dr. Campbell could write the letter. **The vote carried 6-0.**
