#### 1.0 Call to Order 7:00 PM

1.1 Mr. Pizano called the School Committee Meeting to order. 7:00 PM

#### 1.2 Pledge of Allegiance

In our commitment to lifelong learning, we acknowledge historical injustices to the native people of this land and vow to educate ourselves, our community, and our students on the First Peoples and the hardships they endured. We offer this as a small, but essential, step towards building a culture of respect, truth, and accountability."

Members of the School Committee and Selectboard will receive introductions, ask questions, and, by majority vote, select the person to temporarily fill Ms. Michelle Badger's open School Committee seat through May 17, 2025.

The following candidates spoke to the School Committee and Select board:

- Ms.Bethany Rogers
- Ms.Christina Bryant

Each candidate had 15 minutes to introduce themselves and answer the questions sent out before the meeting, as well as any questions that committee members may have.

After the candidates answered questions the committee moved to the nomination process.

- Mr. Golden nominated Ronann Buchanan, seconded by Mr. Bletzer.
- Ms.Shaw nominated Bethany Rogers seconded by Mr. Canty.
- Ms. Jackson nominated Christina Bryant seconded by Dr. Sorensen
- Dr. Sorensen nominated Margaret Matthews seconded by Mr. Morgan.

Ronan Buchanan: Mr. Mogan, Mr. Golden, and Mr. Bletzer 3 votes.

Bethany Rogers: Mr. Canty, Ms. Shaw, and Mr. Pizano. 3 votes.

Christina Bryant: Mr. Mahoney, Ms. Heywood, Ms. Jackson, Dr. Sorensen, and Mr. Quintal. 5 votes. Margaret Matthews 0 votes.

\*Another round of voting took place as there was no majority.

Discussion was had among the committee in support of their candidate of choice. Dr. Sorensen and Ms. Jackson advocated for Ms. Christina Bryant to be the nominee. Ms. Shaw, Mr. Canty and Mr. Pizano lobbied for Ms. Bethany Rogers. Mr. Golden Mr. Bletzer and Mr. Morgan advocated for Mr. Ronan Buchanan.

Mr. Ronan Buchanan- 3 votes

Ms.Rogers- 3 votes

Ms.Christina Bryant -5 votes.

\*The committee selected to do a 'sub-run-off'

A vote was taken between two candidates Ronan Buchanan and Bethany Rogers.

Ms. Heywood pointed out that both Ronan Buchanan and Bethany Rogers are former students in our community.

Lobbying continued for the two candidates.

Dr. Sorenen questioned Ronan Buchanan's readiness to be on the committee.

The sub-run-off vote was: 4 votes for Ronan Buchanan. 7 votes Bethany Rogers.

The final vote was between Christina Bryant and Bethany Rogers.

The vote was 4 votes for Bethany Rogers and 6 votes for Christina Bryant. Mr. Golden abstained.

Ms.Christina Byant will fill Michelle Badger's seat until May 2025.

**Superintendent's Recommendation:** That Plymouth School Committee nominate and appoint by majority vote a new school committee member to fill Ms. Michelle Badger's seat through the Plymouth May 2025 Election.

Mr. Pizano motioned to adjourn the joint session seconded by Mr. Canty. Mr. Quintal motioned to close the select board motion by Mr. Canty seconded by Mr. Mahoney.
